### TERMS AND CONDITIONS

To participate in the SRP Home Performance with ENERGY STAR program, the following conditions apply:

- › The homeowner must be a current SRP residential customer and reside in a single-family detached home, a single-family attached home (duplex, triplex or quadplex ONLY) or an apartment/condominium (duplex, triplex or quadplex ONLY).
- › The homeowner must abide by the rules and rebate levels in effect at the date the Home Performance audit is received by SRP. For current program requirements and program effective dates, go to [savewithsrp.com](http://savewithsrp.com) or call the SRP Home Performance answer line at (602) 889-2656. Completion of an audit does not guarantee availability of rebate funds.
- › The homeowner is responsible for the \$99 Home Performance audit payment. A customer receipt for \$99 from the contractor must be submitted with the rebate application.
- › The contracting company performing the Home Performance audit must be on the list of qualified contractors for the SRP Home Performance with ENERGY STAR program.
- › The Home Performance with ENERGY STAR audit and recommendations are valid for five years from the initial audit date.
- › SRP customers are eligible for only one Home Performance audit per address every five years.
- › Multifamily dwellings greater than four units do not qualify for the SRP Home Performance with ENERGY STAR program.
- › Manufactured or mobile homes do not qualify for the SRP Home Performance with ENERGY STAR program.
- › Program procedures, requirements and rebate levels are subject to change or cancellation without notice. Rebates will be issued at the **THEN CURRENT** funding levels at the time the measures are completed and not at the time of the initial audit.
- › Failure to provide any of the required information, including signatures, will result in the denial of the Home Performance audit and all associated rebates.
